










On-Resistance vs. Gate-to-Source Voltage



**Threshold Voltage** 




Single Pulse Power, Junction-to-Ambient









Power Derating, Junction-to-Foot



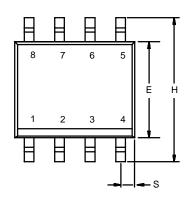
#### Normalized Thermal Transient Impedance, Junction-to-Ambient
