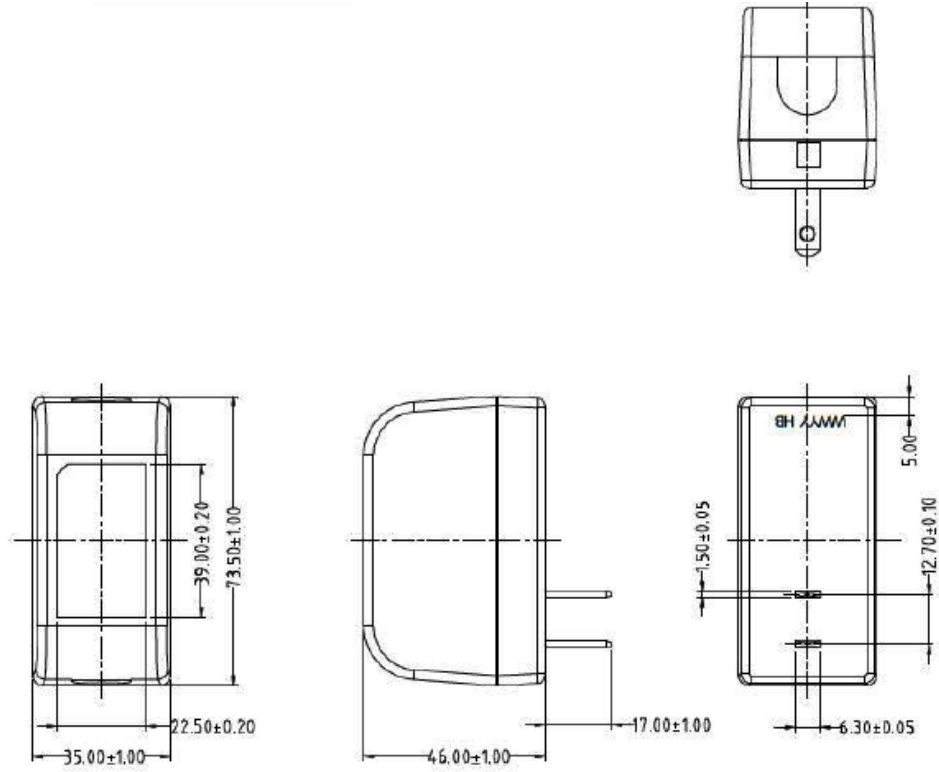

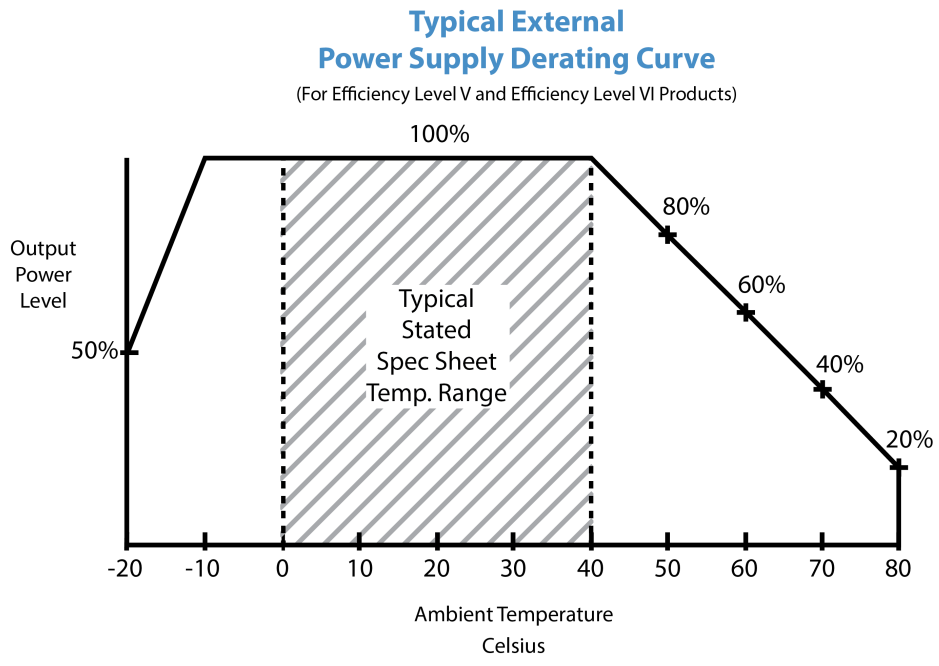

DERATING CURVE

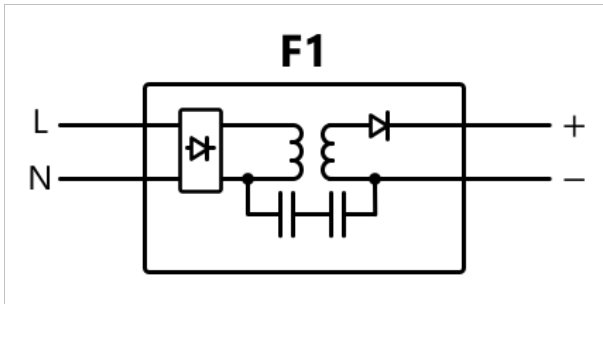
