






## N-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted





 $V_{GS}$  - Gate-to-Source Voltage (V) On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power (Junction-to-Ambient)



Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot

#### P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






### P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted


