1. General description

The 74LV244AT is an 8-bit buffer/line driver with 3-state outputs and TTL inputs. The device features two output enables (1 \overline{OE} and 2 \overline{OE}). A HIGH on n \overline{OE} causes the associated outputs to assume a high-impedance OFF-state.

Designed to operate over a V_{CC} range from 4.5 V to 5.5 V, the inputs are TTL compatible, which allows the device to be used to translate from 3.3 V to 5 V.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial Power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.









Propagation delay input (An) to output (Yn) Fig. 3.



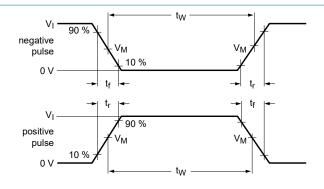



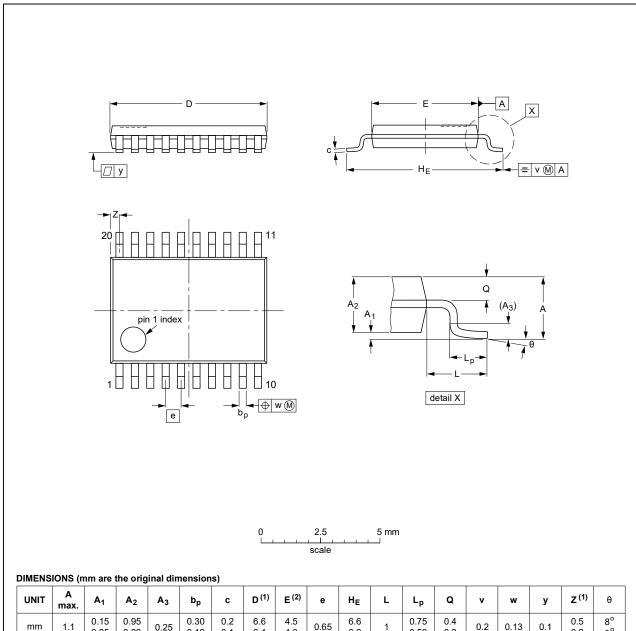
