


On-Resistance vs. Drain Current








On-Resistance vs. Junction Temperature










### **Source Drain Diode Forward Voltage**






**Drain Source Breakdown vs. Junction Temperature**


Safe Operating Area





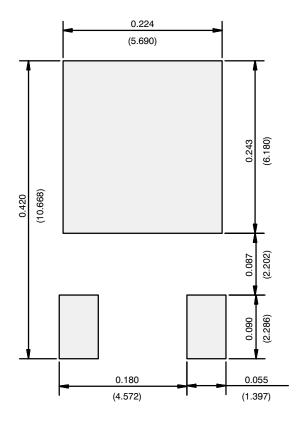
