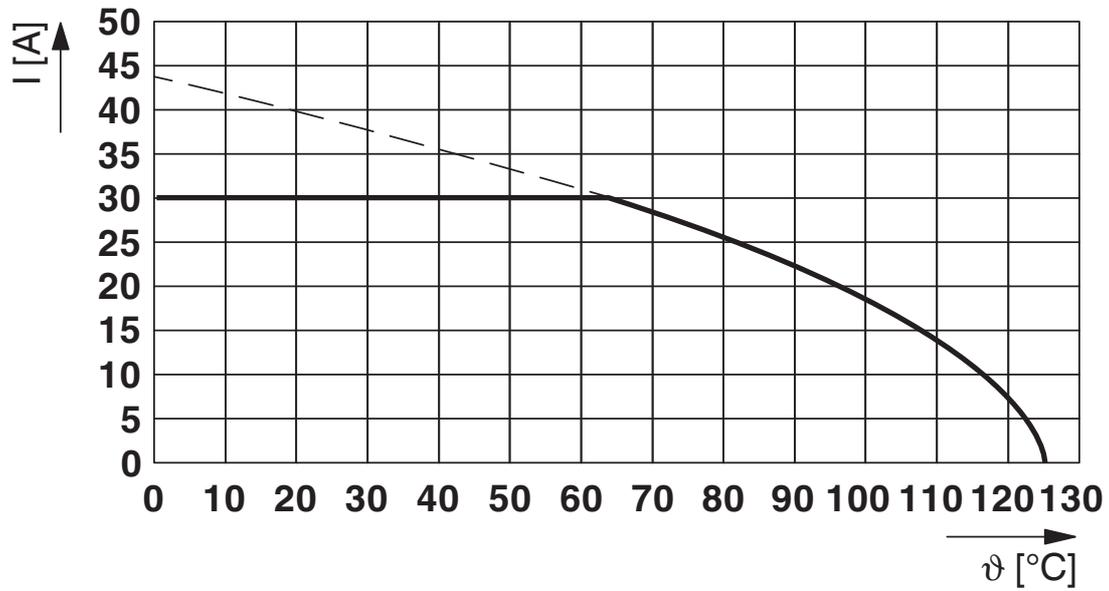

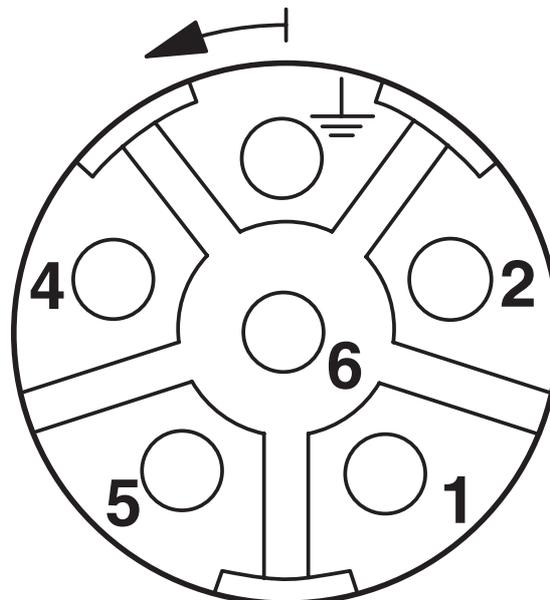

Schematic diagram



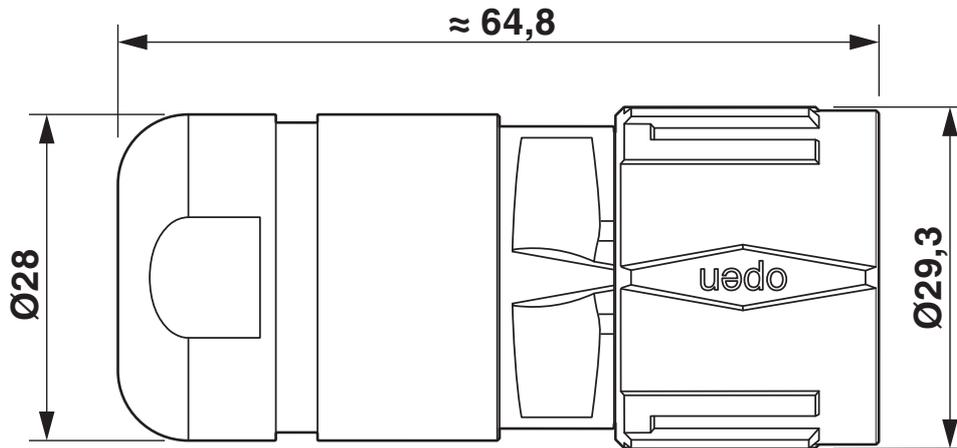
