







#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted









Source-Drain Diode Forward Voltage




Drain Source Breakdown vs. Junction Temperature

Threshold Voltage





Single Pulse Avalanche Current Capability vs. Time


