






#### Source-Drain Diode Forward Voltage



 $V_{\text{GS}}$  - Gate-to-Source Voltage (V) On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient


Safe Operating Area






T<sub>C</sub> - Case Temperature (°C)

Power, Junction-to-Foot




Power Derating, Junction-to-Ambient

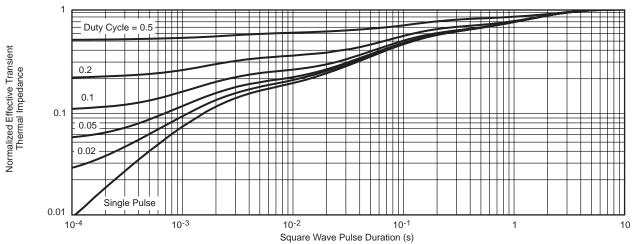


#### Normalized Thermal Transient Impedance, Junction-to-Ambient
