




TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)






On-Resistance vs. Junction Temperature



Threshold Voltage





Drain Source Breakdown vs. Junction Temperature

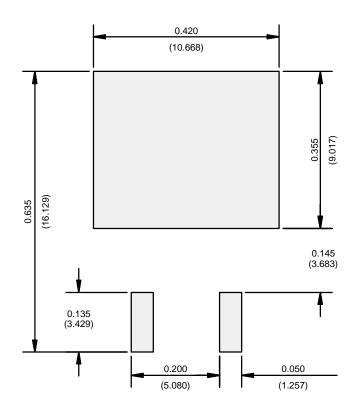




Normalized Thermal Transient Impedance, Junction-to-Case
